## WHY CREATE AN ALL-AMERICAN CLUB YEARBOOK?

I'm going to mimic a recent television commercial by asking,

**“Why create an All American Club Yearbook?”**  
**“Why now?”..... “Why not?”**

Here are some answers.

- It would give your club an excellent record of 2009;
- If you've never done one before, it can be a tool to examine your club's strong points and where you need to put more effort in the future;
- If you have put together a book in the past, a comparison of this year to past years can also be an effective tool - what's changed, what's good, what needs improvement, have we been moving in the right direction - all good things to look at and weigh;
- It can pull club members together around a common goal, each adding their own talents and strengths to the project; and most importantly
- It can act as a focal point at your Show or at your meetings to attract potential new members.

In the past, I have written a series of articles for the *AFMS Newsletter* giving hints and suggestions about how you can tackle this project. It is, by no means, a simple task, but it is one that can be done with a plan in mind and with the help of a group of members.

## NEW IRS INFORMATION

The IRS announced new user filing fees for applications for exemption (Forms 1023 and 1024) postmarked after January 3, 2010.

- \$400 if gross receipts are \$10,00 or less over a 4-year period.
- \$850.00 if gross receipts exceed \$10,000 annually over a 4-year period

Cyber Assistant, a web-based software program designed to help 501(c) (3) applicants prepare a complete and accurate Form 1023 application, will become available during 2010. Once the IRS announces the availability of Cyber Assistant. The user fee will change again:

- \$200 for organizations using Cyber Assistant for Form 1023 (regardless of size)
- \$850 all other organizations not using Cyber Assistant for Form 1023 (regardless of size).

IRS will announce when Cyber Assistant is available and the effective date of the user fee change.

have information on Cyber Assistant such as cost, if any.

Keep in mind Cyber Assistant will only apply to Form 1023.

The IRS website has substantial information available for charities. A new on-line tool will help complete the 2008 Form 990. More important is a mini-course overview of Form 990-EZ. Changes in the filing thresholds make many more organizations eligible to file Form 990-EZ.



## LILLIAN S. TURNER

Lillian Turner was one of those "behind the scenes" people whose determination made things happen. Sadly, she passed away on September 27 at the age of 91.

A modest woman, she preferred to remain in the background and as a result, for many, the "rockhound" accomplishments of Lillian Turner are unknown. She was instrumental in getting the postal service to issue two sets of mineral stamps -- best sellers for USPS because the entire inventory quickly sold out and it's rumored that many still remain uncirculated. Until age prevented her from being more active, Lillian continued to work with the Citizens Stamp Advisory Board on trying to obtain additional postal issues. Lillian also donated a sum of money to the AFMS for the establishment of the "Lillian Turner Award" - a savings bond given to the junior having the best competitive display during the AFMS annual convention. She also established a similar award for her local club, the Gem, Lapidary and Mineral Society of Montgomery Co. MD.

If you've ever visited the Smithsonian, you may have noticed the "Mysterious Diamond", a nearly black stone on display in the diamond case in the gem hall. That stone, which she donated, is about a half dollar in size, but extremely thin. It's mounting artfully hides the fact that it's so thin. In 1987 she was instrumental in obtaining the donation of the 5-carat red diamond, one of the largest such stones known by working with Sydney DeYoung, a Boston jeweler she had met during her travels. Several jade pieces were also donated to the Smithsonian and at least one remains on display in the Geology gallery. She was also friendly with Harry Winston and others, and probably influenced additional gem donations.

Lillian would periodically call my home and we'd chat for 30 minutes or so. She was fascinating to talk with, always sharing some information about her collection of jade, or famous diamond replicas or carved birds. She generously shared parts of these collections each year during the GLMS/MC annual show and always offered to take me on a "personal tour" whenever she and I were at the show together. She loved to regale me with stories about how she had obtained each of the items. She had a connection with Baltimore, my hometown, and loved to talk about its history and museums. We also shared a love of poodles and she never failed to ask about mine. Good memories of a fabulous lady.

She is survived by her son, Dr. Stephen Turner of Winston-Salem, NC, a niece and a nephew. Contributions in her memory may be made to the AFMS Scholarship Foundation, % your regional federation chair person.

## 2010 AFMS PROGRAM COMPETITION RULES



The purpose of this Competition is to Recognize and Reward authors of presentations about the Earth Sciences and to make winning programs available to affiliated Clubs across the country. Video, digital presentations or slides, relating to the Earth Sciences are eligible. Submit entries in one of the four amateur classes or "**Excellence in Education**" for "commercial" presentations.

- Each program is judged on its own merits.
- Entrants in amateur categories will receive a composite score sheet with comments / score.
- Judging Form and "Tips for Good Programs" are available on AFMS website ([www.amfed.org](http://www.amfed.org)) from AFMS Coordinator or your Regional Program Librarian.

### WHO MAY ENTER

Any Club, Society, or members thereof, with 2010 dues paid to a Federation affiliated with AFMS may enter. (Does not apply to "Excellence in Education" entries.)

### DEADLINE for entry: April 15, 2010

### CLASSES FOR ENTRIES

Class 1 -Educational - about geology, minerals, gems, fossils, etc.

Class 2 -Field Collecting - showing site(s), specimens, with some geology, collecting methods and other aspects of interest.

Class 3 -"How To Do It" - techniques/equipment for fossil prep. jewelry, metal work, carving, faceting, other lapidary, etc.

Class 4 -"Just for Juniors" - any of the above for/ by youngsters.

"Excellence in Education" entries are judged separately.

### JUDGING (Judges look for:)

- accuracy of information / educational value
- quality of photographs / visuals
- completeness of story - but not "too much" information
- narration that moves well from one image to the next
- presentations that explore an area of interest or demonstrate ideas/techniques which viewers may try
- title, credits and "The End" "slides" where needed, phonetic spelling of unfamiliar words in "script" example: Sault Ste. Marie (SUE saint marie)

### For CD, DVD or VIDEO entries

- submit a copy
- may be 'live action' or static slides
- integrated audio is greatly appreciated but not required

### For SLIDE PRESENTATIONS

- must be 35mm, in standard mounts.
- should be relatively new originals, though historic slides can be appropriate in some presentations.

- must be spotted for projection, preferably with a red dot in lower left corner and coded with entrant's initials.

- must be numbered to match script.
- a script (written narration indicating when each slide is to be projected) preferably typed, ready for duplication. (sample formats are available upon request) Script on a "floppy" or CD is very helpful but not required.

### AWARDS

A \$200 cash prize for the highest scoring program (with 95+ points),

\$100 if score is 94 - 90 points, (for highest score) in each Class 1 - 4.

In addition, Winners receive national recognition.

A copy of each winning program is given to each Regional Program Library; thus winning programs are available to Clubs across the country. Winners will be announced at the AFMS Awards Banquet at La Habre CA, June 19, 2010

### PROGRAM LENGTH

Adult programs: 30 - 40 minutes is optimum; Juniors: 20 minutes suggested maximum.

### REPRODUCTION / DUPLICATION

By entering, all winners grant permission for AFMS to duplicate / transfer their entry to DVD format for the Regional Libraries. 35mm slides will be scanned, then returned to producer. Digital entries can be returned after duplication if requested. Non-winners will be returned after AFMS Convention. AFMS will take reasonable precautions to protect program while it is in our hands.

## HAVING FUN: JUNIOR ACTIVITIES SUPPORTING SCHOOL CLUBS

Three years ago, elementary school teacher Michael Putney from New York state contacted me to tell me he had formed a geology club, the Mineral Minds, and asked if he might use the AFMS/FRA Badge Program, which he had run across on the web. I encouraged him to get a local club within the Eastern Federation to sponsor him. Instead, he took the extra step of submitting an application to join the Eastern Federation as an independent juniors-only club. In the three years since, we've distributed 127 membership badges to kids within Mineral Minds, awarded 200 activities badges, and recognized 8 members for earning their Rockhound badges. A great success by any measure!

In my own Ventura Gem & Mineral Society (VGMS) here in California, member Lowell Foster is also an elementary school teacher and last year started a geology club in his school, with kids from fifth and sixth grade. Via his VGMS affiliation, he was aware of the AFMS/FRA badge program, and starting this year, he's making activities from that program a centerpiece of his school club and has asked if VGMS might serve as a sponsor as a possible intermediary step toward applying to the California Federation as an independent juniors-only club. The VGMS Directors happily approved that request just last night. (Of course, it helps that I'm VGMS President and Lowell is our First Vice President, but still...)

Are there elementary, junior or senior high school teachers in your club or society? Might they be interested in sharing their love of our hobby and avocation with kids in their schools? If so, lend them a hand, and provide sponsorship for a school club. As part of VGMS sponsorship for Lowell's club, we'll be providing rocks, minerals, and fossils from our club rock pile, encouraging members to give the occasional talk or demonstration, loaning club cases for the kids to display at local gem shows and the county fair, and so on. And if you don't happen to have teachers in your club, check around the local schools to see if there's a Michael Putney or a Lowell Foster near you. (Incidentally, Michael and Lowell are now in touch and plan to do bi-coastal rock swaps - a Herkimer diamond for some California serpentine, a New York garnet for a Hauser Bed geode, etc.) Before you know it, you might be having fun!

## AFMS CERTIFIED JUDGING COURSE AT WILDACRES

I greatly appreciate the opportunity I was given to attend this course at the Wildacres workshop hosted by Eastern Federation of Mineralogical and Lapidary Societies, Inc.

Course description was "an in-depth look at the AFMS Uniform Rules and how they apply to exhibits". Our panel consisted of representatives from the 7 (seven) Federations and representatives from the AFMS Uniform Rules committee.

Our instructor, B. Jay Bowman read from the manual (line by line) and made sure we ALL understood the meaning of what had been read.

After attending the Uniform Rules Committee meeting in Billings, MT I had a lot of questions. Completion of this course enabled me to understand the subtle points as well as the major concepts in the Uniform Rules. Input from the panel with our diverse representation from all the Federations gave us insight into how the Uniform Rules work in all parts of the country.

Although I am still not an expert on many of the Divisions I feel confident that I can make a significant contribution to any judging team that I am part of. Knowing what the rules say and/or where to find the information is imperative to being an effective judge.

We judged 6 (six) exhibit cases in teams. Each member of the team brought insights through their own experiences. Jay reviewed our score sheets and made comments when necessary. I am working on not being so critical (crowded cases and gaps in liners drive me crazy!).

I believe this course in the Wildacres Workshop setting is a very effective way to learn. The information is very intense and one can only absorb so much information per day.

We are the sum total of our experiences and I thank everyone I came in contact with at Wildacres.

## INTER-REGIONAL FIELD TRIPS

The AFMS ad hoc committee for Inter Regional Field Trips was established to promote and conduct interaction between the members of the Federations of AFMS. And when I say members I don't mean the clubs or the officers, I mean the people. The rockhounds! Prior to establishing this committee the interaction between Federations typically only happened at an AFMS combined meeting and show. And this basically has been limited to the Federations' officers and the committees. While the stated purpose of this committee is to hold and promote field trips, I think the scope could be expanded to include rock swaps, seminars, classes, and the like.

A difference between an "Inter Regional Field Trip" and a Federation field trip or a club trip basically comes down to who is invited, how the trip is promoted and where it is promoted. I receive and read several other Federation newsletters and have become aware of a number of field trips and related events that could easily fit the criteria of an "inter-regional trip/event". By its' nature an inter-regional field trip is probably bigger than most other field trips and therefore requires more thought and planning. Since the purpose is to attract a broader geographical attendance the collecting opportunity should be for material that is of good quality and good supply, and easily obtainable by both experienced and inexperienced rockhounds. This event can and should offer those attending more than just collecting. It should provide opportunities for socializing and interaction: potluck dinners, happy hour get togethers, and evening campfires. There can be other attractions and activities such as speakers from BLM/Forest Service/local experts, map exchanges and "home" material swap, special sight seeing attractions like a National Park, and other collecting sights in the area or on the way.

So far we have held two Inter-Regional Rockhound Rendezvous in the western Federations. These were well attended and were great fun. What we need now is some inter-regional trips/events east of the Rocky Mountains. What we need is for some interested people to step up to organize and host an event. Now is the time to start planning our next Rendezvous or event. I am here to help. Send me your ideas or questions. And we don't need to limit ourselves to one event a year.

Where will our next Rendezvous be and who will host it?

My plan is to have two judges for each regional competition (their scores for each contestant will be averaged) and one judge for the AFMS level. Each pair of judges probably will be judging two or three different regions, but they will not be judging their own region. Right now I have a total of three judges for sure, and possibly another two. I must have at least four more judges, preferably an additional 11 judges. If I can get a total of 14 judges, each pair will judge the entrants from only one regional federation.

If you are a current (or former) webmaster or are very Web-site savvy, please help make the contest a success by volunteering a little of your time to act as a judge. Read the Guidelines to see what the judges will be looking for on the sites that they judge, and contact me at <pgeorge4@comcast.net> to help this fledgling contest be an even bigger success in its second year.

And now I have a plea. Someone volunteering to be a judge sent me an e-mail the last day of August or during the first three days of September. I was in the hospital at that time and didn't have an Internet connection to be able to respond (my son had copied my unread e-mails to a laptop computer and brought it to the hospital so I could at least see them). Since returning home I have searched for that e-mail, and I absolutely cannot find it. Would whoever sent that e-mail to me PLEASE contact me again? Your background sounded like you would be an excellent judge, and I would like to add you to my list of judges.
